LOCKUP JERKED OFF. 3 TIME TODAY
SEPT. 15. FORGOT MY BAIL 10,500.00

BREAKFAST FOR CIGARETTES SO I'LL
FUCKING BE HUNGRY ALL DAY. + TO
TOP IT OFF IM SITTING IN MY CELL
FREEING WITH A BLANKET WRAPPED AROUND
ME FROM 5-9. DID AN INTERVIEW WITH
TERRY AT 9:30 FOR HIS BOOK. PLAYED CARDS

ME SOME OF HER HAIR + CHEWED

I NEED BAIL BADLY. I FEEL LIKE IM
BEING USED. BUT REALLY IT'S MIKE. IT'S
THIS UTTER CONFUSION THAT I FEEL,
IT IS PHYSICALLY + MENTALLY STRAINING.
DECEPTION, FEAR, ANGER, BETRAYAL.
IT'S VERY HARD FOR ME TO GRASP
WHAT THEIR PLANS WILL BE FOR ME.
BUT I MUST KEEP MYSELF COMMITTED

GG ALLIN

On October 22nd, 1991, **GG Allin** was instructed by his parole agent, _____ that he could no longer leave the state of Michigan and perform with his rock and roll band the *Murder Junkies*. The reason, _____ stated, was that Allin verbally assaulted an audience during a performance in Santa Barbara, California - although no arrest was made. With this, _____ took it upon himself to play the role of censor by putting a restriction on Allin stating that he would be violated and sent back to prison if he left Michigan and continued to perform. Parole or no parole, the state has no right to deny the right to work or to earn his livelihood and means of survival. This is clearly a violation of Allin's constitutional rights to freedom of speech and expression. Within a few weeks Allin had no choice but to violate his parole and go on tour. Allin's only alternative would have been to remain in the state of Michigan with no money, no work, and rotting in the sewers of Ann Arbor.

_____ should have taken the time to at least investigate the allegations of the Santa Barbara incident in more detail as this situation could have more than likely been resolved - he failed to do so. Who is to say what is verbally assaultive to an audience? If that were the case, Allin would be in violation every time he performed any one of his songs.

It is also mentioned in the enclosed parole report that Allin was arrested in Orlando, Florida a few weeks later for exposing his sex organs, cutting himself and bleeding on the audience, as the police report states. Allin pleads not guilty. Those in the audience paid to see it...Freedom of expression. These charges should be ruled out as well. Whatever happened to the phrase "Innocent until proven guilty?" Allin was arrested again in Austin, Texas on February 18th, 1992 for another performance. No charges were brought up against him, however, when they ran his name through a computer, a warrant for his arrest appeared in the state of Michigan. Allin was then extradited back to the state of Michigan where he remains today.

Who was really violated here?

GG ALLIN was violated, that's who!!

This is a clear case of discrimination against a performer. Allin should not be in prison... not for verbally assaulting his audience or performing his rock and roll. This is an absurd justice.
